

# WEBSITE PRIVACY POLICY [WWW.BARLEYCUP.COM]

## 1. General information.

1. The Operator of the Website [www.barleycup.com](http://www.barleycup.com), [www.barleycup.co.uk](http://www.barleycup.co.uk), is Grana sp. z o.o., ul. Piłsudskiego 1, 32-050 Skawina, Poland.

2. The Website collects information about its users and their behaviour in the following ways:
  - a. Information voluntarily submitted via forms on the Website.
  - b. By saving cookies onto the end user's device.
  - c. The collecting of server logs by the hosting service provider Ogicom Spider Sp. z o.o. S.K.A., which operates the website [www.ogicom.pl](http://www.ogicom.pl).

## 2. GDPR information

In accordance with Article 13 of the General Data Protection Regulation of 27 April 2016 (O. J. EU L 119 of 04/05/2016), please be informed that:

- 1) The controller of your personal data is Grana sp. z o.o., 32-050 Skawina, ul. Piłsudskiego 1
- 2) The personal data is collected by being voluntarily entered in forms (first name, last name, e-mail address, telephone number)
- 3) Personal data (e.g. time of visit, IP address, URL address, browser, location data, etc.) is collected for statistical purposes by the hosting operator H88 S.A. with its registered office in Poznań, ul. Franklina Roosevelta 22, 60-829 Poznań, operating at [www.ogicom.pl](http://www.ogicom.pl) in accordance with the Personal Data Processing Agreement with Grana Sp. z o.o.
- 4) Your personal data is stored for a period of 12 months.
- 5) In relation to our processing of your personal data, you have the following rights:
  - The right to request access to your personal data, to have it rectified, deleted or its processing restricted,
  - The right to object to processing,
  - The right to transfer your data,
  - The right to withdraw your consent to personal data processing for a specific purpose if you have given such a consent earlier,
  - The right to complain to the supervisory authority in relation to our processing of personal data.

## 3. Information about cookies.

1. The Website uses cookies.
2. Cookies are data, specifically text files, stored on the Website User's end device and are intended to be used in some sections of the Website. Usually, cookies contain the name of the site they stem from, the time of their creation on the end device, and a unique number.
3. The Website Operator is the entity which creates cookies on the Website User's end device and accesses them.
4. Cookies are used for the following purposes:
  - a. for compiling statistics which help the operator to understand how the Website Users use the website, which allows for improving the structure and content.
  - b. for conveniently sustaining the Website User's session (after logging in); this ensures that the User does not have to enter his or her login and password on each section of the Website;
  - c. for profiling the User in order to display to him or her targeted materials in advertising networks, in particular in from the Google network.
5. The Website uses two fundamental types of cookies: session cookies and persistent cookies. Session cookies are temporary files which are stored on the User's end device until they log out, leave the site or close the software (web browser). Persistent cookies are stored on the User's end device for a period specified in the cookie parameters or until they are removed by the User.
6. The software used for browsing websites (the web browser) usually allows for storing cookies on the User's end device by default. The Website Users may change the settings in this respect. The web

browser allows for the removal of cookies. It is also possible to automatically block cookies. Detailed information is provided in the help section or documentation of the web browser.

7. Restrictions on the use of cookies may affect certain functionalities available on sections of the website.
8. Cookies placed on the Website User's end device may also be used by advertisers and partners which cooperate with the Website Operator.

10. Cookies may be used by advertising networks, in particular the Google network, for displaying advertisements targeted to the manner in which the User uses the website. To this end, they may store information about the User's navigation path or the time spent on a particular page.

## 4. Server logs.

1. Information about certain behaviours of Users is logged on the server. Such data is used exclusively for the administration of the Website and to ensure the most efficient hosting service possible.
2. Resources viewed by the User are identified by URL addresses. In addition, the following data may be saved:
  - a. The time of the query
  - b. The time of the response
  - c. The name of the client's station - identified by the HTTP protocol
  - d. Information about any errors which may have occurred during the HTTP transaction
  - e. The URL address of the site which was previously visited by the User (the referrer link) - only if the User accessed the website through a link
  - f. Information about the User's web browser
  - g. The User's IP address
3. This data is not associated with any specific person viewing the website.
4. This data is not used only for the administration of the website.

## 5. Making data available.

1. The data is to be made available to third parties only to the extent permissible by law.
2. Data which can be used to identify an individual is made available only with the consent of the person to whom the data is associated.
3. The Operator may be obliged to provide information collected by the Website to authorised bodies pursuant to their lawful requests and to the extent of the request only.

## 6. Managing cookies - how to express and withdraw your consent?

1. If you do not wish to receive cookies, you may change the cookie settings of your web browser. If the User disables the cookies required for the processes of authentication, security or for storing the User's preferences, this may impair the correct functioning of many websites.
